## Explanation of Responses:

- The securities are directly held by jVen Capital, LLC ("jVen Capital"). Mr. Jones is managing member of jVen Capital and may be deemed to have voting and dispositive power over the shares owned by jVen Capital.
- The securities are directly held by Cynthia Jones, the wife of Mr. Jones.
- Each share of Series A Redeemable Convertible Preferred Stock will automatically convert into one share of common stock on May 8, 2015.
- The 2014 Convertible Notes will automatically convert into shares of Series A Preferred Stock on May 8, 2015 at a conversion rate of one share of Series A Preferred Stock for every \$1.00 of principal converted. Each share of Series A Preferred Stock will automatically convert into one share of common stock on May 8, 2015.
- The 2015 Convertible Notes will convert into Series A Preferred Stock on May 8, 2015 at a conversion rate of 1.25 shares of Series A Preferred Stock for each \$1.00 of principal converted. Each share of Series A Preferred stock will automatically convert into one share of common stock on May 8, 2015.
- The option fully vested on June 19, 2010.
- The option fully vested on April 15, 2010.
- The option vested 25% on April 24, 2015, the remainder quarterly thereafter in equal proportions over a three-year period.
- The option vests 25% on October 23, 2015, the remainder quarterly thereafter in equal proportions over a three-year period.
